The author identified key points of differentiation among the various models; this level of detail is very helpful to the router user in making a tool selection. We are pleased that the Bosch 1613AEVS rated well under the objective guidelines; however, the array of items included with the 1613AEVS needs clarification. The 1613AEVS includes the router, templet guide (bushing) adapter, dust collection hood with hose adapter, and drop-forged wrench. The kit version of this tool, the 1613AEVSK, includes all of those items plus a rugged carrying case. The base adjustment device (RA1150 centering cone) and templet guides (bushings) are optional accessories.
