

f you're just getting started in the building business and have the good sense to read Quenda Behler Story's *Contractor's Plain-English Legal Guide* (Craftsman Book Company, 2002; 800/829-8123, www.craftsmanbook.com; \$49.50), you'll have received one of your first and best warnings that you're facing a rough road ahead. And that's the good



news. Let's face it, if you're risk-averse, you might be happier in another line of work. There are scheming clients out there just waiting to play their own, litigation-driven version of Chicken. One of the worst scenarios for a builder is to wind up in court, battling for his or her paycheck, reputation, or survival.

The author has a knack for imparting clarity to the legal realities confronting building professionals. Her guide covers the bases from business startup to full steam ahead and on to retirement without lapsing into Latinese. When you do encounter the occasional *quantum meruit* or *caveat emptor*, it's in the context of a clear translation. Does she cover *all* the bases? Well... is there a limit to human mischief, folly, and inventiveness?


Nevertheless, as stated in the guide's introduction, you can certainly save yourself a few \$300-per-hour legal bills over the long haul by taking heed of the advice offered.

Adding to the utility of the book is a CD full of legal form blanks, contracts, waivers, and notices in Adobe PDF and Rich Text (RTF) formats.

If you're already in a fix, the *Legal Guide* may or may not get you all the way over those troubled waters. But, until you're forced to hook up with your own flesh-and-blood attorney, don't let this reliable counselor gather dust on your bookshelf.

The Six Ps

Building projects take on a life of their own. And, like it or not, they take a hefty piece of your life, too. "Building houses is not a 9-to-5 or a Monday-through-Friday job," state John J. Haasl and Peter Kuchinsky II, authors of *Production Checklist for Builders and Superintendents* (Home Builder Press, 2001; 800/223-2665, www.builderbooks.com; \$37). The authors stake their faith and base their book on what they call "the Six Ps: Prior Proper Planning Prevents

Poor Performance." To keep errors and omissions from mounting an attack on your construction schedule, they say, you need some kind of detailed road map to follow and maybe a log of where you've been.

Not a narrative, this is a book of lists: 137 pages of detailed items to check off along the path of the building project, from prejob planning to the final payment. Developed from 50 years of combined experience in home building and construction, the lists seem exhaustive, although that's probably not possible given the unique nature of most homes and every client. However, this is far better than starting your own lists from scratch. And you can always paste in special items as the need arises, especially given the included floppy diskette containing all the checklists in MS-Word format (sorry, Mac users — IBM compatibles only). In fact, if nothing more, the book is a complete, annotated reference to the diskette's contents.

Appendixes "A" and "B" contain, respectively, a Typical Construction Schedule and a detailed item list of Sample Pay Schedule Ratios, or draws on the contract.

Applied by the supervisor in the field, these checklists could provide a dynamic record of where you are, where you're going, and where you've been, information that can otherwise get lost or confused in the heat of the battle. If you hate paperwork, just remember how much more you hate screwing up. Again.
